- 1 About us**
- 1.1 This competition is administered by English Path, the trading name of Language Path Education Limited, a company registered in England with registration number 13312625, whose registered address is: 891 Greenford Road, Greenford, London UB6 0HE.
- 2 The Competition**
- 2.1 For the purposes of these Terms and Conditions, the "Promoter" refers to English Path Online.
- 2.2 The "Prize" refers to up to 12 weeks of the Online General English Course (valued up to £720). Three winners will be announced on Thursday 29<sup>th</sup> February 2024.
- 2.3 By entering the competition, you agree to be bound by these terms and conditions.
- 3 How to enter**
