### TRAVEL

Students enrolled on Young Learner programme must book a transfer unless parents/guardian have made arrangements to drop their child off at school or EP provided accommodation.

An arrival and departure taxi transfer is strongly advised for all students including those aged 16 and 17.

We use a reputable taxi transfer company where all the drivers have been DBS checked. Your son/daughter will be met at arrivals and taken directly to their home stay accommodation.

On receipt of all arrival details, we will send you a confirmation of the transfer outlining the procedures in place to ensure that your child gets from the airport to their accommodation safely.

If a family member or guardian is meeting your child aged 16 & 17 (on adult course) at the airport, please complete the below section of this form.

If you choose not to book an arrival/departure transfer for your child aged 16 & 17 (on adult course), you should be aware of the following issues:

- Immigration officers (passport control at the airport) may not allow a child with no one at the airport to greet them to enter the UK.
- Your son/daughter will be travelling on public transport to an unfamiliar location.
- Please ensure you have checked the journey from the airport to the host family together before they fly.
- Ensure they have our emergency telephone number so we can assist, if required.
